Caniatewyd ymchwiliad cynllunio ar gyfer dau gaban pren, yn amodol ar amodau, un o'r rhai oedd gan y Departament Ffyrdd yn yr ystyr o ddiogelwch ffyrdd, a ddywedodd, "Mae'r llety byw wedi'i gytuno yma yn gysylltiedig â defnyddio'r anedd brif ac ni chaiff ei feddianu ar unrhyw adeg fel uned ar wahân nac yn uned gyswilt o lety parhaol nac y defnyddir yn gydwethredol ag unrhyw fenter fasnachol." Roedd y cais cynllunio eilradd (A240100) yn ymwneud â mynediadau ar wahân a llwyfannau ar gyfer y ddau gabin a gymeradwywyd gyda'r un amod â'r cais cynharach gan y Departament Ffyrdd.

Felly, rydym yn cwestiynu creu menter newydd, sef llety B&B yn Llys y Nant, gan ei fod yn torri'r claus uchod a'r ffaith ei fod yn cael ei gynllunio'n wreiddiol ar gyfer defnydd gan y teulu estynedig.

#### Planning Applications

##### 10.01 A230651 Pigeonsford Mandion – appeal letter

It was agreed to send the following written representations;

Llangrannog Community Council wish to draw your attention to the following matters :

- 1) Previous internal renovations carried out by the current owners are both tasteful and in-keeping with the character of this significant historical building.
- 2) We note that the LPA does not object to the proposed internal renovations.
- 3) With reference to the LPA's concerns about the proposed rear extension, Llangrannog Community Council's observations are as follows :-
  - a) the proposed atrium extension is not visible from the adjacent public footpath so it would not affect the overall appearance of the building.
  - b) a possible compromise would be to reduce the scale of the extension, and also the intrinsic trellis work could be simplified in order to maintain the architectural integrity of the present features of the Grade II listed building.

##### 10.02 A230428 Llys y Nant – appeal letter

Llangrannog Community Council wish to draw your attention to the following matters :-

- 1) The original planning application (A220769) was for additional accommodation for family members only.

Planning permission was granted for two wooden cabins, subject to conditions, one of which was from the Highways Department in the interest of road safety that stated,

"The annexed living accommodation hereby approved shall be incidental to the use of the main dwelling and shall not be occupied at any time as a separate unit and associated unit of permanent accommodation or used in conjunction with any commercial venture".

The second planning application (A240100) was for separate entrances and decking for both cabins which was approved with the same proviso as the previous application from the Highways Department.

We therefore query the creation of a new enterprise, viz, B&B accommodation at Llys y Nant, as it contravenes the above mentioned clause and the fact that it was originally intended for use by the extended family.

- 2) Road Safety :

The Community Council re-iterates its concern for

Nid yw'r ardal ar gyfer y safle parcio newydd a gynhelir yn y ffordd yn ymarferol gan ei bod yn gulach na'r un presennol.

Fodd bynnag, pe byddai pobl eraill yn ymweld a pharcio eu ceir y tu allan i'r safle sydd ar gornel, ni fyddai digon o le ar gyfer 2 gar i basio gan arwain at alw'n y traffig.

- b) Diogelwch cerddwyr yn cerdded ar y darn hwn o'r B4321, oherwydd y cynnydd sylweddol yn y traffig. Mae hefyd grwpiau mawr o blant a thiwtoriaid sy'n aros yn y Ganolfan Urdd sy'n aml yn cerdded heibio'r safle ar eu ffordd i draeth Llangrannog. Gall cyfuniad o geir parcio ar y gornel y tu allan i Llys y Nant, yn ogystal â hedfan traffig dwy ffordd, fod yn broblemu i gerddwyr ac i unrhyw ddefnyddwyr eraill o'r ffordd sydd yn cynnwys cerbydau brys.

11.03 A250283 Maesybryn Farm, Pentregat

Dim sylwadau neu gwrtwynebiad.

- a) the lack of off-road parking at the site. The current hashed area as shown on the plans isn't suitable in its current state for off road parking. Please see below picture which shows the black vehicles driver side wheel already encroaching onto the road. The area for the new proposed roadside parking is not feasible as it is narrower than the existing one – please refer to picture.

However, should other people visit and park their cars outside the site which is located on a bend, there would be insufficient room for 2 cars to pass leading to traffic congestion.

- b) The safety of pedestrians walking on this stretch of the B4321, due to the high volume of traffic. There are also large groups of children and teachers staying at the Urdd Centre who often walk past the site on their way to Llangrannog beach. A combination of parked cars on the bend outside Llys y Nant, as well as two way traffic could potentially prove problematic for pedestrians and all other road users which includes emergency vehicles.
