Clerk to contact the committee. 24.04 Hywel Dda Consultation There is an online event this Thursday at 6.30pm for Town and Community Councils to attend to discuss the Clinical Services Plan Consultation. 24.03 Councillor Training Plan Defer until the next meeting. 24.04 Feedback questionnaire following the Code of Conduct training by CCC on the 11/2/25 Councillors in attendance completed the questionnaire with the Clerk. 24.05 Review of community arrangements of the County of Ceredigion Following the recent announcement, it was agreed to write to One Voice Wales to ask if it is possible to challenge the decision. It was also agreed to write to the elections department of Ceredigion County Council to ask what exactly the arrangements will be and how the County will support us. 24.06 Ceredigion County Councils review of the 20mph speed limit Ceredigion County Council has undertaken a comprehensive review of the 20mph speed limits across the county, following a request from the Welsh Government to gather residents' feedback about the new limits that were introduced in September 2023. The Welsh Government provided new '30mph exception' guidance in 2024 to assist Local Authorities with this exercise. The attached document summarises this review, the key criteria in the guidance, and the outcome of no changes to speed limits. In June 2024 Ceredigion County Council received requests from various Community Councils relating to this review via Elin Jones AM. Llangrannog Community Council requested arrangements on the

Llangrannog am gynnwys trefniadau ar yr C1012 o'r gyffordd â Pigeonsford i'r gyffordd â'r lôn i Fferm Penrallt yn yr adolygiad. Gan ddefnyddio canllawiau Llywodraeth Cymru yn agos, ni chododd unrhyw newid i'r trefniadau am y rhesymau canlynol:

Roedd cyflymderau cyn Medi 2023 eisoes yn isel, a dim ond 315m o hyd yw'r ffordd, felly newid dibwys mewn amseroedd teithio. Does dim troedffordd, ac mae'r ffordd yn gul, gyda cherbydau mwy yn gwrthdaro.

Gwnaed cais hefyd am derfyn cyflymder is ym Blaencelyn, a oedd y tu allan i gwmpas yr adolygiad hwn. Fel y soniwyd yn y crynodeb atodedig o'r adolygiad, mae Llywodraeth Cymru wedi hysbysu awdurdodau lleol ei bod yn bwriadu cyhoeddi canllawiau newydd pellach ar gyfer pennu terfynau cyflymder lleol ac mae disgwyl y bydd awdurdodau priffyrdd lleol yn adolygu terfynau cyflymder ar ffyrdd a oedd y tu allan i gwmpas y newid cenedlaethol i derfynau cyflymder yn 2023. Bydd unrhyw newidiadau i derfynau cyflymder ar ffyrdd sy'n dod o dan awdurdodaeth Cyngor Sir Ceredigion yn amodol ar argaeledd adnoddau i gynnal adolygiad ac yna i weithredu unrhyw newidiadau sy'n deillio o'r adolygiad hwn.

Cafwyd cais hefyd ynglŷn â'r terfyn cyflymder ar yr A487 ym Mhentregât, nad oes gan y Cyngor awdurdodaeth drosti. Dylid cyfeirio'r cais hwn at Lywodraeth Cymru yn uniongyrchol.

24.07 E-bost gan breswilydd – torri gwair a dessau

Derbyniwyd e-bost oddi wrth preswilydd yn gofyn am ddiweddariad ar y fainc wedi'u torri. Trafododd y cynghorwyr y fainc a cytunwyd i gael pris am 2 fainc newydd ar gyfer Heol y Garreg a Blaencelyn yn gyntaf. Yn ymwneud a torri porfa, dylai'r Clerc esbonio bod y Cyngor Cymuned yn gyfrifol am dorri'r cae ger Neuadd Pontgarreg ac o amgylch y fainc sy'n perthyn i'r Cyngor Cymuned. Byddai pob ardal arall yn gyfrifoldeb Cyngor Sirol Ceredigion a dylid annog iddynt e-bostio drwy clic@ceredigion.gov.uk.

C1012 from the junction with Pigeonsford to the junction with the lane to Penrallt Farm be included in the review. Using the Welsh Government guidance closely, no change to arrangements arose for the following reasons:

Speeds pre-Sept 2023 already low, and the road is only 315m in length, so insignificant change in travel times. There is no footway, and the road is narrow, with larger vehicles coming into conflict.

A request was also made for a lower speed limit at Blaencelyn, which was outside the scope of this review. As mentioned in the attached summary of the review, the Welsh Government has informed local authorities that it intends publishing further new guidance for setting local speed limits and there is an expectation that local highway authorities will review speed limits on roads that were outside the scope of national change to speed limits in 2023. Any changes to speed limits on roads that fall under the jurisdiction of Ceredigion County Council will be subject to the availability of resources to undertake a review and then to implement any changes arising from this review.

A request was also received regarding the speed limit on the A487 at Pentregat, on which the Council has no jurisdiction. This request should be addressed to the Welsh Government directly.

24.07 Email from resident – broken benches, grass cutting and weeding

An email was received from a resident seeking an update on the broken benches. Councillors discussed the benches and it was agreed to get a price for 2 new composite benches for Heol y Garreg and Blaencelyn initially. With regards to the grass cutting and weeding, Clerk to explain that the Community Council is responsible to cut the field by Pontgarreg Hall and also around the benches that belong to the Community Council. All other areas would be the responsibility of Ceredigion County Council and urge then to email via clic@ceredigion.gov.uk.
