72.01 Llangrannog Toilets

The Clerk received a response thanking the
Community Council for their contribution for the year
2026/27. The contribution will be treated as a
bridging arrangement while Ceredigion County
Council continues to review the long-term
sustainability of the service. As part of that work, we
will continue to explore options with a view to
achieving full cost recovery in the future, including
revisiting community-led solutions or alternative
models once there is greater clarity following the
Boundary Commission changes.
