Cllr Lloyd reported that there had been a number of successful events held recently in preparation for the National Eisteddfod in August, one of the events was the celebrate of Lord Rhys which visited Talgarreg and Llangrannog.

Cllr Lloyd informed members that the fundraising committee for the National Eisteddfod have began their campaign to decorate communities in preparation for the event. If anyone is interested, they can contact they committee directly.

Cllr Lloyd informed members that Llandysiliogogo Community Council have recently sent correspondence to Siân Gwenllian the Welsh Government's Cabinet Minister for Local Government, Housing and Planning, MP's representing Ceredigion and Preseli, Ceredigion County Councillors and Town and Community Council's in Ceredigion.

The Clerk informed members that the email had been shared with them and other Town and Community Council's but the email had been send as a blind copy due to email addresses.

Cllr Lloyd reported that he had recently attended a positive site meeting with officers from Ceredigion County Council regarding a coastal defence scheme for Llangrannog. There will be a period of review where officers will look at how to take the scheme forward initially. Cllr Lloyd urged officers to ensure that a public consultation would be held and all local groups and residents would have the opportunity to participate. There is no confirmed date as yet for this piece of work but Cllr Lloyd hoped it would be before the end of the year.
